### What is PB and what does it look like?

PB is essentially a way for people to decide on how public money should be spent. Participatory budgeting allows people to identify, discuss, and prioritise public spending projects, and gives them the power to make real decisions about how money is spent.

In Scotland this looks like:

- **Small Grants PB** Use of small pots of money/grants
- Mainstreaming Participatory Budgeting The public decides where public money is spent through a fair and transparent process (including deliberation and voting)

## Key Features of PB

The PB Charter outlines the key principles underpinning PB as follows:

#### PB should be ...

- Fair and inclusive
- Participatory
- Deliberative
- Empowering
- Creative and flexible
- Transparent
- Part of our democracy

#### Benefits of PB

- build strong relationships between people, communities and public organisations;
- build trust between people and make joint action possible;
- encourage democratic participation by reducing barriers to involvement and making sure that everyone who wants to take part can do so;
- target resources to where they are most needed;
- encourage the testing of new ideas to help transform communities in a positive way; and;
- make sure that everyone who is affected can see how decisions about budgets are taken, how money is spent, and what happens as a result;

# What and Why Green PB?

The use of PB principles and processes to increase opportunities for communities and citizens to have a greater say in how money is spent to achieve climate action and just transition goals.

- Shifting local attitudes and increasing both awareness and understanding of Climate Change and associated issues
- Presenting opportunities for people who want to be part of the climate change solution to turn their sense of joint responsibility into a real purpose
- Reducing carbon footprints and contribute to the net-zero agenda for Scotland whilst improving the health and wellbeing of both local people and their communities.
- Encouraging creative ideas about local climate change opportunities and generating sustainable projects for local benefit that have a measurable effect on the quality of life, carbon footprint and polluting emissions of local areas.

## National PB Journey?

- Since 2014/15, SG has invested £6.5 million through the Community Choices Fund with local authorities providing match funding of almost £1.5m
- Mainstreaming Budgets. Agreement in October 2017 between the Scottish Government (SG) and COSLA that at least 1% of council budgets will be subject to PB by 2020/21 (although with some flexibility due to the impact of COVID-19)
- Participatory Budgetary recognised by the Just Transition Commission as a way forward:

"Recommendation 13. To place people at the centre of local climate action, Scottish Government and COSLA should implement Green Participatory Budgeting with explicit recognition of just transition principles, and agree to target levels of funding".



## **Green PB National Commitment**

**Programme for Government** 

A Fairer, Greener Scotland Programme for Government 2021-22 Published 7 September 2021 - Page 55 – Table, Row 3

Implement Green Participatory Budgeting with agreed target levels of funding We will explore the use of Participatory Budgeting in 2021-22 as part of our wider support for community-led climate action. We will also identify opportunities at COP26 to develop the concept of Participatory Budgeting for climate action – both in Scotland and abroad – and identify opportunities to develop programmes specifically involving schools and young people. We will work with local authorities to embed climate principles into wider participatory budgeting initiatives, building on the agreement between the Scottish Government and COSLA that at least 1% of council budgets will be subject to Participatory Budgeting by 2021-22.


